**SESSION:** SNF QRP/VBP: The Evolution Continues...

SUMMARY: Today more than ever, it is critical for skilled nursing facilities to produce exceptional quality outcomes. The transition to value-based reimbursement is here and it can have a significant impact on your organizations Medicare payments, marketability, strategic planning and much more. With the MDS changes coming in October 2023, new requirements from Final Rule making, and anticipated future Final Rule changes, these quality programs are evolving and raising expectations for the long-term care industry.

This session will review the technical components of both the SNF Value Based Purchasing program and the Quality Reporting Program and discuss strategies to help prepare facilities for the shift in approach these programs will demand to avoid payment penalties and improve quality outcomes.

**SESSION:** Mindshield: Practical Strategies for Long-Term Care Leaders to Keep You & Your Team Motivated, Focused, and In the Game (and Avoiding Burnout)

**SUMMARY:** According to the Harvard Business Review, beyond the human toll on mental health, physical health and relationships, burnout of key leaders is an expensive problem:

- Employers spend roughly \$190B in burnoutrelated healthcare costs each year.
- Workplace stress is estimated to cost the U.S. economy more than \$500 billion dollars a year, with lost productivity amounting to about 550 million workdays.
- Caregivers, like doctors and nurses, are especially vulnerable to burnout, contributing to tremendously high suicide rates: Men have a 40 percent higher risk of suicide and for women, it's 130 percent higher.
- Toxic cultures pay for their attitude in turnover cost each. Average turnover is about 17.8% across all industries. Replacing an employee cost an average of 33% of their salary, depending on the position.

• For a company of 100 employees with an average annual turnover rate, assuming everyone who leaves is entry-mid level, that is an annual cost of \$1.7 million.

If you are like most leaders in healthcare, the impact of the pandemic and economic instability on you, your staff and your leadership has been profound. You have been focused on solving the persistent problems of staffing shortages while retaining your best people so you can provide the highest quality of care for a vulnerable population. It has been an exhausting sprint, but you can't sprint forever.

As we talk to the healthcare leaders, the biggest challenges we are hearing are how to keep themselves and their people physically and psychologically safe, motivated, and focused on critical tasks and patient care because the overwhelming progression of stressors you and your team continue to face include:

- Recruitment and retention of well-trained and motivated clinical and administrative staff.
- Inability to deliver consistent, high quality care due to staffing shortages.
- Rapidly shifting healthcare landscape.
- Constant mental strain on the home front for all of us (kids at home, spouse out of work, elderly or ill parents).

Under the program, 2% of SNF FFS Medicare Part A payments are withheld and 60% are redistributed to SNFs as incentive payments for performance. This session will focus on

- Identify potential causes and plan best practices to prevent hospital readmissions following SNF discharge.

Margins and Operating Efficiencies are being threatened by COVID, increased regulatory oversight, labor shortages, expense inflation, and stagnant reimbursement. Without a proper understanding of these challenges, providers risk higher costs, lower margins, and regulatory penalties which reduce reimbursement. This session will include a detailed discussion of recent changes to the Nursing Home operating environment, including Medicaid reimbursement, minimum staffing requirements, and the "70/40/5" rules. The session will also discuss several operating challenges, how each challenge is measured quantitatively and qualitatively, and the strategies to avoid hitting operating pitfalls.
