Gearing Up for the Mandatory Office of Inspector General (OIG) Compliance Plan By Tom Ealey

The Legal and Managerial Environment

In 2009, the Patient Protection Accountability and Affordability Act [Title VI, Subtitle B, Sec. 6102] moved long term care conformity to a new realm by making a compliance and ethics plan *mandatory*. The date in which this will be mandated has yet to be determined.

History and Background:

In 2000 and 2008, the OIG issued compliance recommendations for long term care. (2000 OIG Compliance Recommendations) and 2008 OIG Compliance Recommendations)

A compliance plan can be considered evidence of *good faith* during audits and investigations in federal sentencing considerations. Our goal is to avoid ever getting close to a federal criminal proceeding.

In order to develop a compliance plan to meet the Patient Protection Accountability and Affordability Act, facilities must invest both money and staff time into the project. However, compliance can be good business. Just as many facilities use self-survey to monitor quality and regulatory compliance, the self-audit features of this plan can improve billing, documentation, and quality of care.

The Long Term Care Bull's-eye

OIG guidance statements, for other providers, focus on billing integrity. However, for long term care, this emphasis has evolved into something broader: *the quality of care*. Quality of care includes reducing fraud and abuse, enhancing health care providers' operations, improving the quality of health care services, and reducing their overall cost.

The Long-term Care Advantage

Much of the work required by a formal compliance program is already being completed by long term care facilities. New regulations, however, will require a more formal management framework and more documentation. Nonetheless, a well managed compliance plan could prevent regulatory, billing and financial problems, making compliance a money saving function.

Compliance Basics

The OIG guidance statements are not intended to represent complete compliance plans, but outline basic requirements. The seven standard OIG recommendations for compliance plans are:

- 1. Designation of a compliance officer and compliance committee;
- Development of compliance policies and procedures, including standards of conduct;
- 3. Developing open lines of communications;
- 4. Providing appropriate training and teaching;
- 5. Developing internal monitoring and auditing;
- 6. Responding to detected deficiencies; and
- 7. Enforcing disciplinary standards.

Effective plans are not derived from *cookbook* sources, or written to sit on a shelf. There is plenty of work ahead for many facilities, as the plan should be customized to fit a specific facility with specific needs.

Fraud and Abuse Risk Areas

The OIG lists several operational categories in long-term care facilities ("ltcfs") presenting liability risks to the provider. The OIG expands on these areas of concern listed below.

1. Billing Integrity

Billing integrity is a major focus of the OIG. In fact, with other providers, billing integrity is the bulk of the concern. Not so long-term care.

The OIG specifically mentions concerns well understood in the long-term care industry 1) duplicate billing 2) Insufficient documentation and 3) false or fraudulent costs reports.

2. Comprehensive Resident Care Plans

The OIG considers resident care plan as an essential element of reducing risk. OIG **is** particularly concerned that resident care plans are...

- appropriately scheduled to allow full team attendance.
- include the physician in the planning process. (Continued on page 4)

- include complete clinical assessment before the meeting.
- involve open lines of communication among all members of the team.
- involve the resident, family, and any legal guardian in a Plan of Action (POA).
- document the length and content of each meeting.

3. Sufficient Staffing

Quality is often measured in terms of quantity of employees. While the OIG reviews the quantity, they put a specific focus on the appropriate clinical expertise of the employees.

4. Medication Management and Use of Psychotrophic Medications

Management processes must be put in place to advance patient safety, minimize drug interactions, and insure discovery and correction or irregularities. Psychotrophic medications create risks of violating two standards of care: inappropriate use of chemical restraints and a requirement to avoid unnecessary drug usage.

5. Resident Safety – mistreatment, neglect, abuse:

The OIG wants an effective compliance program to prevent or investigate/respond to incidences related to: 1. staff-on-resident abuse and neglect 2. resident-on-resident abuse, 3. abuse from unknown causes or sources. A confidential internal reporting mechanism and appropriate follow up are key any resident safety programs.

6. Anti-supplementation:

Medicare and Medicaid payments are designed, subject to available co-insurance or co-payments, as payment in full for covered items and services. Beneficiaries or any person in lieu of the beneficiary (e.g., family member, guardian) may be required to supplement the payments.

7. Anti-Kickback Regulations

Providers cannot buy or reward referrals of government funded residents. Compliance programs should monitor facility conduct with regard to purchases of goods, services and leases, as well as prohibiting direct or indirect payment or remuneration for referrals.

Gearing Up

Although, the final regulations are not written and the exact startup date is not yet known, there is no reason to wait to being gearing up a formal compliance program. First, look for the places where the work is already being done. This is where selfassessment and self-survey can be incorporated. Then, begin to build the formal structure needed for the plan. The plan can and should be customized to the size of the facility and the complexity of the care provided. There is not a one size fits all plan that can be implemented.

The heart of compliance is this – documenting sound management practices, quality care, and process integrity. With or without the government, this should always be our mission.





Ending Hospital Readmissions is one of the timeliest and informative books I have read in quite awhile. The author, Barbara Acello, RN, begins by defining the problem of readmissions from SNFs to hospitals in a way that is understandable and logical. This book steers away from abstract thoughts by providing clear and concise descriptions of facts.


Ms. Acello unmistakably defines the causes of avoidable hospitalizations. In the text, the importance of communication between doctors, nurses, and discharge planners from both hospitals and SNFs are emphasized. The analysis of The Weekend Exodus was of particular interest. After thoroughly describing and analyzing the scope of the problem, numerous solutions are offered which could prove invaluable to long term care nurses and administrators.

The book also provides a wealth of resources throughout the appendices. These contain tools and checklists which will assist in early detection of problems and will provide guidance for staff to avoid non-essential transfers.

This book is highly recommended as a resource for all long term care nurses and administrators. In today's health care environment, the content of this book should be a part of the normal orientation and in-service training of all nursing personnel. The cost of this book will be miniscule in comparison to the savings it can bring if the suggestions presented are properly implemented.
