He is a former member of the Oklahoma Alliance on Aging Board of Directors and has served as an AHCA Silver Quality Award examiner and as a member of the AHCA Quality Award Board of Overseers.

Bob has spoken multiple times at ACHCA and AHCA national meetings and in more than 16 states. Bob is a 2016 graduate of the United Way of Central Oklahoma's Board Serve program and serves as a board member and Vice President of Upward Transitions in Oklahoma City. He and his wife, Rose, volunteer for Central Oklahoma Habitat for Humanity, and various community activities through their church, St. Mark Lutheran Church and Preschool in Edmond, OK.

He is a graduate of The University of Kansas, Lawrence, with a bachelor's degree in allied health administration, and a graduate of The University of Oklahoma, Norman, with a graduate certificate in gerontology and a master's degree in health and human services administration.
